I WAS DISPATCHED TO ADDRESS INVOLVING A MAN WHO WAS SHOOTING A FIREARM AND THE FIREARM EXPLODED IN HIS FACE. DEPUTY GALBREATH AND MYSELF RESPONDED TO THE SCENE. WE ARRIVED ON SCENE AS NEW CONCORD SQUAD WAS LEAVING THE SCENE WITH THE VICTIM. I MET THE OWNER AND WITNESS OF THE INCIDENT AND IDENTIFIED HIM AS MATTHEW WOOD. MATTHEW TOOK ME TO THE SCENE WHERE THE INCIDENT OCCURRED. MATTHEW ADVISED THAT GLEN UNDERWOOD AND HIMSELF WERE TARGET SHOOTING MUZZLE LOADERS FOR THE UPCOMING DEER SEASON. THEY WERE SHOOTING AT TWO TARGETS AT DIFFERENT DISTANCES IN A FIELD. THEY WERE SHOOTING FROM A RAILING LOCATED BESIDE MATTHEW'S GARAGE. MATTHEW ADVISED THAT HE WAS WORKING ON HIS MUZZLE LOADER WHILE GLEN WAS SHOOTING WHEN HE HEARD AN "EXPLOSION" BEHIND HIM. HE ADVISED HE LOOKED AT GLEN AND SEEN THAT GLEN WAS HOLDING HIS FACE AND HE WAS BLEEDING HEAVILY. HE ADVISED THAT HE RAN INTO THE HOUSE, CALLED 911 AND PUT A TOWEL AROUND GLEN'S FACE.

UPON LOOKING AT THE SCENE OF THE INCIDENT, THERE WAS A LARGE SPOT OF BLOOD ON THE CEMENT NEAR THE RAILING. A PLASTIC CHAIR WAS SITTING NEAR THE POOL OF BLOOD. THE CHAIR ALSO HAD BLOOD ON THE RIGHT HANDLE AND LEG. THE WOODEN STOCK OF THE GUN WAS SHATTERED INTO THREE PIECES AND WAS LAYING AROUND THE BLOOD. THE BARREL, SCOPE AND FRONT HALF OF THE RECEIVER WAS LAYING ON THE RAILING. THE END OF THE BARREL WAS FACING THE TARGETS. THE BREECH PLUG WAS MISSING FROM THE RECEIVER AND WAS NEVER LOCATED. THE BOTTOM REAR END OF THE SCOPE WAS DAMAGED WHICH APPEARED TO BE FROM THE BREECH PLUG BEING EJECTED FROM THE RECEIVER. **THE MUZZLE LOADER WAS A .45 CALIBER KODIAK MAGNUM WITH A SCOPE SERIAL NUMBER 61-13-104092-04.** PHOTOS WERE TAKEN OF THE SCENE AND THE GUN PARTS WERE TAKEN INTO EVIDENCE.

MATTHEW ADVISED THAT THIS PARTICULAR ROUND WAS THE FIRST ROUND FIRED FROM THE MUZZLE LOADER THAT DAY. GLEN HAD FIRED A .50 CALIBER RIFLE BEFORE HE FIRED THE .45 CALIBER RIFLE. MATTHEW ADVISED THAT HE WAS NOT SURE HOW MUCH POWDER GLEN WAS USING WITH THE MUZZLE LOADER. THE MUZZLE LOADER AND PYRODEX POWDER TABLETS WERE TAKEN INTO EVIDENCE

GLEN WAS AIR LIFTED TO GRANT HOSPITAL FROM SOUTHEAST MED.
