I own a CVA Hunterbolt Magnum rifle. On a recent hunt we nearly lost a hunter because of a product design defect. The trigger mechanism is held to the barrel by two screws. One of the screws had come loose (no locking mechanism on the screw) due to normal use. This allowed the trigger assembly to drop slightly, which allowed the firing pin to slip forward once the bolt was engaged. The firing pin slipped (snapped) onto the cap causing the gun to fire, even though the safety was on, and the trigger was not touched. When I took the gun completely apart (barrel off stock) and noticed the loose screw holding the trigger to the barrel, then I could understand why the gun fired dangerously next to a fellow hunter. I called CVA and waited for 15 minutes to talk to a customer service person who denied any problem. Can you suggest how to get some action? There must be a lot of hunters out there with this gun, about to experience the same problem. Can you help me prevent a disaster?
